Beasley - S. Jones 1. Support the Click It or Ticket Mobilization of May 19, 2014 through June 1, 2014

Supporting the Click It or Ticket Mobilization of May 19-June 1, 2014

WHEREAS, there were 545 motor vehicle fatalities in New Jersey in 2013; and

WHEREAS, a large percentage of the motor vehicle occupants killed in traffic crashes were not wearing a seat belt; and

WHEREAS, use of a seat belt remains the most effective way to avoid death or serious injury in a motor vehicle crash; and

WHEREAS, the National Highway Traffic Safety Administration estimates that 135,000 lives were saved by safety belt usage nationally between 1975-2000; and

WHEREAS, the State of New Jersey will participate in the nationwide Click It or Ticket seat belt mobilization from May 19, 2014 to June 1, 2014 in an effort to raise awareness and increase seat belt usage through a combination of enforcement and education; and

WHEREAS, the Division of Highway Traffic Safety has set a goal of increasing the seat belt usage rate in the state from the current level of 91% to 92%; and

WHEREAS, a further increase in seat belt usage in New Jersey will save lives on our roadways;

RESOLUTION AUTHORIZING A MEMORANDUM OF UNDERSTANDING AMONG THE TOWNSHIP OF IRVINGTON, ESSEX COUNTY, NEW JERSEY, THE TOWNSHIP OF MAPLEWOOD, ESSEX COUNTY, NEW JERSEY AND THE CITY OF ORANGE, ESSEX COUNTY NEW JERSEY REGARDING THE ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY

WHEREAS, the fire departments of the above referenced municipalities habitually work in concert under mutual aid agreements to ensure the safety of the named municipalities and the Essex County region as a whole; and

WHEREAS, the municipal and fire department administration of each municipality have reviewed the benefits of the Assistance to Firefighters Grant (AFG) Program made available by the Federal Department of Emergency Management (FEMA) and understands the advantages of equipping each department with communications devices, frequencies, and training that will facilitate the collaborative fire and rescue activities regularly undertaken by these departments in various locations around the County of Essex and the State of New Jersey; and

WHEREAS, the Township of Irvington, the Township of Maplewood, and the City of Orange, Essex County, New Jersey (partners) have come together to collaborate and make application for the AFG Program; and

WHEREAS, the partners have agreed to enter into a Memorandum of Understanding in which the Township of Irvington will be the lead agency and named applicant and the other entities will be partners in request of the total sum of \$1,276,723 for the purchase of portable radios, mobile radios, base stations, and training required for the use of said equipment;

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL FO THE TOWNSHIP OF IRVINGTON that it is hereby agreed by and among the partners as follows:

- 1. Grant funding will be divided according to the following ratio \$607,697.20 to the Township of Irvington; \$288,746.10 to the Township of Maplewood, and \$380,297.70 to the City of Orange;
- 2. Each partner will dedicate grant and/or matching funds to training for use of the equipment according to the following ratio \$13,100 for Irvington; \$8,300 for Orange, \$6,300 for Maplewood;
- 3. Each partner organization will contribute a matching sum that is equivalent to 10% of the funding allotted to its fire department;
- 4. The Irvington Department of Revenue and Finance will receive grant funds and distribute them to the partner organizations within ten (10) days of receiving said funds;
- 5. Personnel from the Irvington Fire Department will ensure that all required grant reporting is submitted in a timely fashion;
- 6. Personnel from each partner organization will submit information required for reporting to the Irvington Fire Department as requested in a timely fashion;
- 7. Partner organizations will be responsible for the maintenance of their own equipment; and
- 8. Partner organizations will be responsible for separately procuring the equipment that will be used by their fire departments.

WHEREAS, federal regulations at 24 CF Part 91 and Part 92 require that the Township of Irvington prepare and submit a CPMP Fifth Program Year Action Plan as a prerequisite to receipt of entitlement Community Development Block Grant funds and formula HOME Investment Partnerships Program funds; and

WHEREAS, the Township of Irvington, pursuant to the requirements of federal regulation 24 CFR Part 91 and Part 92, has given citizens an opportunity to express their opinions regarding the Township of Irvington, and has held public meetings hearings, which were open to the public; and

RESOLUTION OF NEED IN CONNECTION WITH HMFA APPROVAL OF A PROJECT TO REHABILITATE IRVINGTON SENOR APARTMENTS LOCATED AT 1 LINDEN AVENUE.

S. Jones - Beasley 15. Authorizing Planning Board to Investigate Whether Certain Properties Should be Designated as Areas in Need of Redevelopment

AUTHORIZE THE PLANNING BOARD OF THE TOWNSHIP OF IRVINGTON TO INVESTIGATE WHETHER CERTAIN PROPERTIES IN THE TOWNSHIP SHOULD BE DESIGNATED AS AN AREA IN NEED OF REDEVELOPMENT

WHEREAS, the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1, *et seq.* (the "LRHL"), authorizes municipalities to determine whether certain parcels of land in the municipality constitute areas in need of redevelopment; and

WHEREAS, pursuant to *N.J.S.A.* 40:12A-6 the Township Council of the Township of Irvington (the "Township Council") must authorize the Planning Board of the Township of Irvington (the "Planning Board") to conduct a preliminary investigation of the proposed area and make recommendations to the Township Council; and

WHEREAS, the Township Council by Resolution MC14-0325-12, dated March 25, 2014 (the "Initial Resolution"), directed the Township Administration to identify various individual or contiguous sites which are subject to loans held in private-label securitization trusts ("PLS Loans") within the Township that may qualify as an "area in need of redevelopment" in accordance with *N.J.S.A.* 40A:12A-5 and *N.J.S.A.* 40A:12A-6; and

WHEREAS, the Township Administration prepared a staff report (the "Staff Report") identifying one hundred ninety-nine (199) parcels subject to PLS Loans (collectively, the "Property") located throughout the Township; and

WHEREAS, in connection with completing the Staff Report, the Township Administration conducted an investigation, prepared a map of the Property (the "Proposed Area"), and completed a public hearing on March 31, 2014 at which comments to the designation were received and considered (collectively, the "Due Diligence Investigation"); and

WHEREAS, based on its Due Diligence Investigation, and as set forth in the Staff Report, the Township Administration is recommending the designation of the Proposed Area as an area in need of redevelopment; and

WHEREAS, the Township Council desires to direct the Planning Board to conduct an investigation in accordance with *N.J.S.A.* 40A:12A-6 to determine whether the Proposed Area as

identified in the Staff Report meets the criteria set forth in *N.J.S.A.* 40A:12A-5 to be designated as an area in need of redevelopment; and

WHEREAS, the if the Planning Board investigation determines that the Proposed Area meets the criteria set forth in *N.J.S.A.* 40A:12A-5 to be designated as an area in need of redevelopment, such designation shall authorize the Township to use all those powers provided pursuant to the LRHL for use in a redevelopment area, including the power of eminent domain.

NOW THEREFORE, BE IT RESOLVED by the Municipal Council of the Township of Irvington as follows:

- 1. The Irvington Planning Board is hereby authorized to conduct an investigation pursuant to and in accordance with the procedural requirements of *N.J.S.A.* 40A:12-6, to determine whether the Proposed Area identified in the Staff Report satisfy the criteria set forth in *N.J.S.A.* 40A:12A-5 to be designated as an area in need of redevelopment.
- 2. As part of its investigation, and before proceeding to public hearing on the matter, the Planning Board shall prepare a map showing the boundaries and location of the Proposed Area, and shall append thereto a statement setting forth the basis for the investigation.
- 3. The Planning Board shall conduct a public hearing, after giving due notice of the boundaries and location of the Proposed Area in accordance with the requirements of *N.J.S.A.* 40A:12-6, which notice (i) shall identify the Proposed Area as a "Condemnation Redevelopment Area", and (ii) shall specifically state that a redevelopment area determination shall authorize the Township to exercise the power of eminent domain to acquire the property in the Proposed Area.
- 4. At the hearing, the Planning Board shall hear from all persons who are interested in or would be affected by a determination that the Proposed Area delineated in the notice is a redevelopment area. All objections to a determination that the Proposed Area is an area in need of redevelopment and evidence in support of those objections shall be received and considered by the Planning Board and made part of the public record.
- 5. After conducting its investigation, preparing a map of the boundaries and location of the Proposed Area, and completing a public hearing at which all objections to the designation are received and considered, the Planning Board shall make a recommendation to the Township Council as to whether the Township Council should designate all or some of the Proposed Area as an area in need of redevelopment.
 - 6. This Resolution shall take effect immediately.
