Jones – Jones – Burgess 7. Commemoration – 35th Anniversary of Solid Rock Baptist Church

Resolution of Commemoration Solid Rock Baptist Church 35th Church Anniversary

WHEREAS, the Solid Rock Baptist Church, the church of South Ward Council Member Sandra R. Jones, will be celebrating its 35th Church Anniversary; and

WHEREAS, on December 3, 1979, Deacon Joseph Watts and a group of concerned Christians and former members of the original Hopewell Baptist Church who shared a common love for God and desired to practice Christianity in a Christian like manner, met on serval occasions and organized the church according to the Word of God. Sis. Blonnie Watson arranged the meeting location at High Park Gardens in Newark, NJ where they held their first meeting. After having several meetings at High Park Gardens, Sis. Lucy Ragin was influential in finding a location for the members to have "church" at the St. Charles Auditorium at 77 Custer Avenue in Newark; and

WHEREAS, on Sunday, December 16, 1979, the members held their first 11:00 AM worship service in the St. Charles Auditorium, with Rev. John McGugan preaching the first sermon and had in attendance approximately 100 to 150 members; and

WHEREAS, at the first church meeting on February 8, 1980, a strong Christian board of officers were elected and during that meeting the members also voted to name the church "Solid Rock Baptist Church". At another church meeting held on March 21, 1980, Sis. Jessie Porter became the spiritual mother and Rev. John McGugan became the Pastor of Solid Rock Baptist Church; and

WHEREAS, the Pastor, Officers and Members were ever mindful for the need of a church edifice and all joined in the search for such a place. With the help of God, Deacon

Calvin Venable along with the Official Board, were instrumental in beginning negotiations to purchase 644 Chancellor Avenue; and

WHEREAS, in April 1982, a motorcade was led to the new church home by Pastor Rev. John McGugan and other dignitaries. Solid Rock continued to grow and changes began to take place. During a church meeting on October 29, 1988, Rev. McGugan resigned as pastor of Solid Rock Baptist Church; and

WHEREAS, after months of searching for a new pastor, a church meeting was called on August 18, 1989 and during this meeting Rev. Rudy V. Carlton was voted the new Pastor of Solid Rock Baptist Church. Rev. Carlton was installed as Pastor on October 29, 1989; and

WHEREAS, all founders and members committed to paying \$16 each month for 8 years and in doing so, as well as tithing and fundraising, they raised over \$240,000.00. In December 1989, the church not only celebrated their 10th Church Anniversary but they also celebrated the burning of their mortgage. On July 15, 1990, the laying of the cornerstone was held; and

WHEREAS, Pastor Carlton served as the Pastor of Solid Rock Baptist Church for twelve years until his departure from the church in 2001. After an extensive search and interviewing process in search of a new pastor, on May 10, 2003, Pastor Leonard T. King was accepted by the congregation and the Executive Board as the Pastor of Solid Rock Baptist Church. They believed Pastor King; would lead us in the direction that God would have us to go Pastor King was installed July 23, 2003; and

WHEREAS, in 2008 Solid Rock Baptist Church opened a food pantry and named it in memory of Deacon Venable; and

WHEREAS, in March, 2010, after serving as pastor of Solid Rock for seven years, Rev. Leonard T. King resigned. In December 2010, a new Pulpit Committee was formed and the search began for a new pastor; and

WHEREAS, on December 10, 2011, Solid Rock held its election for a pastor. The church chose Rev. Reginald T. Pitts, from Fountain Baptist Church in Summit. Rev. Pitts accepted the call to become the Pastor of Solid Rock Baptist Church and continues to serve in this capacity; and

WHEREAS, in 2012, through sacrificial giving Solid Rock installed a new heating and air conditioning system. In 2013, Solid Rock endured a renovation both spiritual and physical and their services were relocated to the fellowship hall and the sanctuary was completely renovated:

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that the Municipal Council hereby commemorates the 35th Church Anniversary of Solid Rock Baptist Church and commends Rev. Pitts, the Deacons, Officers and Members for their continued dedication in providing spiritual guidance to the residents of Irvington.

BE IT FURTHER RESOLVED that a copy of this resolution be spread upon the minutes of this governing body in lasting tribute to the 35th Church Anniversary of Solid Rock Baptist Church.
