WHEREAS, to determine whether certain parcels of land constitute an area in need of redevelopment, under the Redevelopment Law the Municipal Council (the "Township Council") of the Township of Irvington (the "Township") must authorize the Township Planning Board (the "Planning Board") to conduct a preliminary investigation of the area and make recommendations to the Township Council; and

WHEREAS, in accordance with the Redevelopment Law and by resolution duly adopted on October 14, 2015 the Township Council authorized the Planning Board to conduct a preliminary investigation of the property commonly known as 60-72 Howard Street, Irvington, NJ and identified as Block 220, Lot 15.01 on the tax map of the Township of Irvington, New Jersey (the "Property"), to determine whether the Property meets the criteria set forth in the Redevelopment Law, and should be designated as an area in need of redevelopment, which designation would authorize the Township and

Township Council to use all those powers permitted by the Redevelopment Law for use in a redevelopment area, other than the power of eminent domain; and

WHEREAS, on January 29, 2016, the Planning Board, after providing due notice, conducted a public hearing in accordance with the Redevelopment Law and determined that the Property qualified as an area in need of redevelopment and recommended that the Township Council designate the Property as an area in need of redevelopment pursuant to the criteria and requirements of the Redevelopment Law; and

WHEREAS, the Township Council has determined that, based upon the recommendations of the Planning Board, Property should be designated an area in need of redevelopment under the Redevelopment Law, such designation authorizing the Township and Township Council to use all those powers provided by the Redevelopment Law for use in a redevelopment area, other than the power of eminent domain.

NOW THEREFORE, BE IT RESOLVED, by the Municipal Council of the Township of Irvington, New Jersey as follows:

Resolution for the Planning Board to Consider Amending the Zoning Ordinance to Restrict the Number of Discount Retail Stores

WHEREAS, the Municipal Council of the Township of Irvington has noted that there is an increasing number of discount stores, also known as "Dollar Stores", and;

WHEREAS, the Municipal Council is concerned that the retail business community needs to be diverse in order to encourage economic development with the Townships as well as offer varied forms of retail stores within the Township, and;

WHEREAS, Dollar stores are not currently addressed within the Township's Zoning Ordinance, and;

WHEREAS, the Municipal Council has no desire to ban such retail establishments but wishes to consider limiting their proliferation within the Township within a defined radius such as 1000 feet.
