## RESOLUTION OF SORROW PASTOR EMERITUS JOHN B. ALSTON

WHEREAS, the Irvington Municipal Council wishes to express their deep sorrow on the passing of Pastor Emeritus John B. Alston on April 12, 2017, who leaves a legacy that will be remembered by many; and

WHEREAS, on April 24,1928 in the small town of Ridgeway, North Carolina, God blessed John Mike and Ella Alston with the birth of their son John B. Alston; and

WHEREAS, accepting Jesus Christ as his personal Savior, John Alston united with the Oak Grove Christian Church in 1943, under the Pastoral Leadership of the Rev. Jim Mike Hargrove. Blessed by God with a remarkable voice, Elder Alston used his musical gift to uplift God's name in song. In 1943, Elder Alston along with his brother Henry, and cousins Raymond and June Jives, formed the St. Andrews Jubilee Singers. This gospel

group became a well- known local favorite. They later became the Gospel Brothers with the addition of Roy Williams; and

WHEREAS, shortly thereafter in 1946, John Alston joined the United States Army. His favorite tour of duty in the military was his assignment to Japan. Upon being honorably discharged from the military, John Alston returned to Henderson, N.C. and continued to sing with the Gospel Brothers. In 1952, he married Geraldine Boyd and to this union he was blessed with his first son Gerald Alston. He later returned to school to complete his education and to study the carpentry trade; and

WHEREAS, Elder Alston received his calling to the ministry on April 24, 1956. Being obedient to God's calling, Elder Alston made a vow to God, promising him that he would preach his unadulterated Gospel. On the third Sunday in May 1957, under the Pastoral leadership of the Rev. Jim Mike Hargrove, Pastor Alston preached his initial sermon "The Prodigal Son". In the same year of 1957, Pastor Alston relocated to New Jersey and united with the St. John Baptist Church in New York City. He later transferred his membership to the Salem Baptist church, under the leadership of the Rev. Johnson; and

WHEREAS, in 1962, he married Geneva D. London, and was blessed with five sons, David, Edward, Michael, Vincent, and the late Danny Ray; and

WHEREAS, in July of 1980, Elder Alston began worshipping with the Mt. Zion Primitive Baptist Church. After the resignation of Pastor Thomas, the Mt. Zion Primitive Baptist Church members inquired upon Elder Alston to bring forth The Word of God. In October 1982, at the church's monthly conference meeting, Elder Alston was elected to an Internship as Pastor of the Mt. Zion Primitive Baptist; and

WHEREAS, Pastor Alston served as Pastor of Mt. Zion Primitive Baptist faithfully for 37 years. Under his Pastoral ship two Elders and one Deacon have been ordained. Many people have been baptized and have accepted Christ through his ministry; and

WHEREAS, in addition to the Pastor's spiritual accomplishments, many organizations have been added to the church. In 1996, God blessed the church through Elder Hagins, an associated Elder of the church to form the Mt. Zion Primitive Baptist Church Help Center. This organization has been a blessing to the church and the community by providing counseling, referrals, financial support, food pantry, homeless prevention center, computer lab and afterschool tutoring; and

NOW, THEREFORE BE IT RESOLVED by the Township of Irvington that the Township of Irvington hereby mourns the loss of Pastor Emeritus John B. Alston and offers its sincerest condolences to his family, friends and congregation during this period of bereavement; and

# RESOLUTION AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$10,500,000 TAX ANTICIPATION NOTES OF CY 2017 OF THE TOWNSHIP OF IRVINGTON, IN THE COUNTY OF ESSEX, NEW JERSEY.

BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF IRVINGTON, IN THE COUNTY OF ESSEX, NEW JERSEY (not less than the majority of the full membership of the governing body) AS FOLLOWS:

Section 1. In anticipation of the collection of taxes during the current fiscal year, we are hereby authorized to be issued tax anticipation notes of the Township, each to be known as "Tax Anticipation Note of CY-2017," in amounts not exceeding \$10,500,000.00. The proceeds of such notes shall be applied only to purposes provided for in the budget or for which taxes are levied for the current year.

Section 2. The following certificate has been prepared by the Director of Revenue and Finance and is filed in the office of the Township Clerk:

#### CERTIFICATE WITH RESPECT TO TAX ANTICIPATION NOTES

I, Faheem J. Ra'Oof, Director of Revenue and Finance of the Township of Irvington, in the County of Essex, New Jersey HEREBY CERTIFY as follows:

- 1. The gross borrowing power in respect to tax anticipation notes for the calendar fiscal year of 2017, being 30 percent of the tax levy for all purposes of the calendar fiscal year of 2016, plus 30 percent of the amount of miscellaneous revenues realized in cash during the calendar fiscal year of 2016, is \$30,479,961.30.
- 2. The amount of notes outstanding in anticipation of the collection of taxes of the calendar fiscal year of 2016, except such notes as will be renewed by or paid from the proceeds of the notes to be issued, is \$ -0-.
- 3. The net borrowing power, being the excess of the first over the second of the two above amounts, is \$30,479,961.30.
- 4. This certificate is made with respect to \$10,500,000.00 Tax Anticipation Notes of CY-2017 about to be authorized by the Township Council of the Township of Irvington.

IN WITNESS WHEREOF, I have hereunto set my hand this 25th day of April, 2017.

Section 3. The following matters in connection with the notes are hereby determined:

- (a) All notes issued hereunder shall mature at such times as may be determined by the Director of Revenue and Finance, provided that no note shall mature later than 120 days following the end of the calendar fiscal year.
- (b) All notes issued hereunder shall bear interest at such rate or rates as may be determined by the Director of Revenue and Finance.
- (c) All notes shall be in the form prescribed by the Local Budget Law and otherwise as determined by the Director of Revenue and Finance and such officer's signature upon the notes shall be conclusive as to such determination;
- (d) Notes issued hereunder may be renewed from time to time, provided, however, that no renewal note shall be issued later than the last day of the fiscal year.
- (e) All notes shall be executed by the Mayor and the Director of Revenue and Finance and attested by the Township Clerk.
- Section 4. The Director of Revenue and Finance is authorized and directed to determine all matters in connection with the notes not determined by this or by a subsequent resolution and such officer's signature upon the notes shall be conclusive as to such determination.

- Section 5. The Director of Revenue and Finance is hereby authorized to sell the notes from time to time at public or private sale in such amounts as such officer may determine at not less than par and to deliver them from time to time to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof and payment therefore.
- Section 6. Any instrument issued pursuant to this resolution shall be a general obligation of the Township, and the full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations.
- Section 7. The Director of Revenue and Finance is authorized and is directed to report in writing to the Township Council at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this resolution is made, such report to include the amount, the description, the interest rate and the maturity of the notes sold, the price obtained and the name of the purchaser.
- Section 8. The Director of Revenue and Finance, in connection with other professionals of the Township acting under his direction, is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document for the Township, as it may be so updated from time to time, to be distributed in connection with the sale of obligations of the Township. The Director of Revenue and Finance is hereby authorized to execute such disclosure document on behalf of the Township.
- Section 9. (a) Solely for purposes of complying with Rule 15c2-12 of the Securities and Exchange Commission (the "Rule"), and provided that an issue of notes authorized by this resolution is not exempt from the Rule and provided that an issue of notes is not exempt from the following requirements in accordance with paragraph (d) of the Rule, for so long as an issue of notes of the Issuer remains outstanding (other than an issue of notes which has been wholly defeased), the Township shall provide in a timely manner to each nationally recognized municipal securities information repository ("National Repositories") or to the Municipal Securities Rulemaking Board, and to the appropriate State information depository, if any, ("State Depository," and together with the National Repositories, the "Repositories") notice of the following events with respect to an issue of notes, if material (herein "Material Events"):
  - (1) Principal and interest payment delinquencies;
  - (2) Non-payment related defaults;
  - (3) Unscheduled draws on debt service reserves reflecting financial

difficulties;

(4) Unscheduled draws on credit enhancements reflecting financial

difficulties;

(5) Substitution of credit or liquidity providers, or their failure to

perform;

(6) Adverse tax opinions or events affecting the tax-exempt status of

the security;

- (7) Modifications to rights of security holders;
- (8) Bond calls;
- (9) Defeasances;

- (10) Release, substitution, or sale of property securing repayment of the securities; and
  - (11) Rating changes.
- (b) The covenants and undertakings contained in this Section are made for the benefit of the holders or beneficial owners of the notes issued under this resolution.
- (c) The Director of Revenue and Finance shall determine, in consultation with Bond Counsel, the application of the Rule or the exemption from the Rule for each issue of notes prior to their offering. Such officer is hereby authorized to enter into written contracts or undertaking to implement this resolution and is further authorized to amend such contracts or undertakings as needed to comply with the Rule or upon the advice of Bond Counsel.
- (d) In the event that the Township fails to comply with this resolution or the written contract or undertaking, the Township shall not be liable for monetary damages, remedy of the holders or beneficial owners of the notes being hereby specifically limited to specific performance of the covenants contained in this resolution or the written contract or undertaking.

Section 10. This resolution shall take effect immediately.

INTRODUCTION OF THE CAMPTOWN BUSINESS IMPROVEMENT DISTRICT FY 2017 ANNUAL BUDGET

WHEREAS, N.J.S.A. 40:56-84 requires that the budget for Special Improvement Districts be introduced in writing at a meeting of the Municipal Council for approval; and

WHEREAS, the Camptown Business Improvement District introduced its FY 2017 budget with a report that explains how the budget contributes to goals and objectives for the special improvement district:

NOW, BE IT THEREFORE RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON the Municipal Council of the Township of Irvington, New Jersey does hereby approve the detailed annual budget for the Camptown Business Improvement District for 2017 and that this approval is subject to all requirements of N.J.S.A. 40:56-84, which includes public notice and hearing.

#### **Budget Overview:**

This year's budget further reduces the CBID tax assessment rate, from 5% (2000-12), 3% (2013-16) and now to 2.5% to provide relief to CBID taxpayers by increasing our carryover fund balance to \$130,961. The 2017 CBID budget continues funding three major program areas: cleaning/maintenance, security cameras, and marketing. The budget continues the higher level of funding of our security camera & property grant programs on private properties in the CBID. The floodlight and cleaning programs maintain their expanded roles over the past two years. Marketing includes possible CBID investment in district property to attract new commercial investment. The CBID's funding for its website and advertisement campaign and its management and administrative operations increases slightly by 2.4%.
