WHEREAS, 100 - 108 Grace Street, LLC is currently developing housing projects in the Township's East Ward, Irvington; specifically six (6) (one) 1 family houses for sale to very low and low income eligible persons or families; and

WHEREAS, 100 - 108 Grace Street, LLC has demonstrated its commitment of redevelopment and revitalization in the East Ward of the Township of Irvington by increasing the supply of affordable housing in the Township of Irvington; and

WHEREAS, the Township of Irvington wishes to support redevelopment and revitalization initiatives throughout the Township of Irvington and has access to abandoned properties located in the targeted area of redevelopment where 100 - 108 Grace Street, LLC; and

WHEREAS, the Township of Irvington Department of Economic Development and Grants Oversight has collected all necessary applications and documentation as well as have taken the steps to access the capacity and ability of 100 - 108 Grace Street, LLC to complete the planned redevelopment; and

WHEREAS, the Township of Irvington, Department of Economic Development and Grants Oversight fully supports and has HOME funds to assist in the financing of affordable housing for low- and moderate-income Irvington families; and

WHEREAS, the Township of Irvington via Resolution No. EDGO17-0110-10 awarded \$120,000.00 in HUD/HOME 100 - 108 Grace Street, LLC for the purposes of GAP funding to complete the project pursuant to the terms of the Redeveloper's Agreement with a total the total project cost is \$1,100,000.00.

WHEREAS, as a result of increased and unanticipated redevelopment costs, the \$120,000.00 will only be applied to three of the six properties at \$40,000.00 each making those units affordable housing. The address and block and lots for these three units are as follows: (1) 106 Grace Street, Block 219 and Lot 6.04; (2) 108 A Grace Street, Block 219 and Lot 6.05; and (3) 108 B Grace Street, Block 219 Lot 6.06.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that the Township does hereby ratify and approve the provision of HUD/HOME Program funds to

100 - 108 Grace Street, LLC in the amount set forth on the request for Approval/Director Authorization Form, in amount of \$120,000.00 to put on file in the Township Clerk's Office; and.

BE IT FURTHER RESOLVED that the aforesaid funds for 100 - 108 Grace Street, LLC are to be used for the new construction and/or rehabilitation of homes for low- and moderate-income Irvington families in the targeted area of redevelopment; and

AMENDMENT OCDP17-0509-4 AUTHORIZING THE SUBMISSION OF FISCAL YEAR 2017-2018 CPMP THIRD ANNUAL ACTION PLAN OF THE TOWNSHIP OF IRVINGTON PURSUANT TO THE REQUIREMENTS OF FEDERAL REGULATION 24 CFR PART 91 AND PART 92.

WHEREAS, Title I of the Housing and Community Development Act of 1974 as amended provides for a program of Community Development Block Grants AND title II of the Cranston-Gonzalez National Affordable Housing Act, as amended provides for a program of HOME Investment Partnerships; and

WHEREAS, the Township of Irvington is an entitlement and formula city as defined under said Acts, and is entitled to financial assistance; and

WHEREAS, the Township of Irvington anticipate that the United State Department of Housing and Urban Development will make available to the Township of Irvington the minimum sum of \$955,920.00 under the Fiscal Year 2017-2018 Community Development Block Grant Program and \$313,619.00 under the HOME Investment Partnerships Program; and

WHEREAS, the Township understands that the stated amount may decrease or increase when HUD officially makes its allocations of the subject funds for Fiscal Year 2017-2018; and

WHEREAS, the Township received final notice of the allotted amount and said notice changed the originally anticipated amount by awarding \$981.416.00 under the Fiscal

Year 2017-2018 Community Development Block Grant Program (CDBG) and \$254.349.00 under the HOME Investment Partnerships Program;

WHEREAS, the Township of Irvington desires to receive said funds to conduct housing rehabilitation, economic development, physical improvements, slum clearance, and public service activities in the Township of Irvington; and

WHEREAS, federal regulations at 24 CF Part 91 and Part 92 require that the Township of Irvington prepare and submit a CPMP Third Program Year Action Plan as a prerequisite to receipt of entitlement Community Development Block Grant funds and formula HOME Investment Partnerships Program funds; and

WHEREAS, the Township of Irvington, pursuant to the requirements of federal regulation 24 CFR Part 91 and Part 92, has given citizens an opportunity to express their opinions regarding the Township of Irvington, and has held public meetings hearings, which were open to the public; and

WHEREAS, said public meetings and hearings were for the purpose of considering and obtaining the views of the citizens of the Township of Irvington on community development and housing needs, and for the purpose of providing the citizens with an opportunity to participate in the development of the CPMP Third Program Year Action Plan; and

WHEREAS, said CPMP Third Program Year Action Plan for federal assistance requires certain certifications to be submitted along with and as part of said plans:

#### **SECTION 1**

1) address life and safety issues in emergency shelters and transitional housing facilities;

WHEREAS, the Township of Irvington is in need of and is interested in creating transitional housing facilities to assist homeless individuals and families transition out of homelessness and into permanent housing with an emphasis on veterans; individuals returning from jail or prison; persons with alcohol/substance abuse issues, victims of domestic violence; persons living with HIV/AIDS; and youth between the ages of 18-21; and

WHEREAS, the Township of Irvington intends to apply for a grant award in the amount of \$400,000.00 to convert one or more township owned properties into transitional housing; and

WHEREAS, the Township of Irvington understands that the amount that may be awarded by the NJ Department of Community Affairs may be less than the \$400,000.00 grant requested and therefore, by adoption of this resolution, the Township also agrees to accept such lesser award amount without the need to amend this herein resolution; and

WHEREAS, the governing body of Irvington Township desires to apply for the Shelter Support Grants administered by the NJ Department of Community;

NOW THEREFORE BE IT RESOLVED by the governing body of Irvington Township in the county of Essex, State of New Jersey, that Irvington Township requests to be considered by the NJ Department of Community Affairs for funding; and

BE IT FURTHER RESOLVED that the governing body of Irvington Township is committed to ensuring that those experiencing periods of homelessness are effectively transitioned out of homelessness into permanent housing; and
