- **WHEREAS**, the <u>Township of Irvington</u> contains properties that are abandoned by their owner and that are in a state of disrepair and neglect contributing to blight;
- **WHEREAS**, said properties by virtue of their condition and proximity to neighboring properties are having a negative effect on said neighboring properties and have a negative effect on the quality of life of adjacent residents and property owners, increasing the risk of damage through arson and vandalism and discouraging neighborhood stability and revitalization; and,
- WHEREAS, many of these buildings or land on which the abandoned properties are situated can be rehabilitated for productive use, which will further the revitalization and redevelopment of the Township of Irvington and improve its economic and social position; and
- **WHEREAS**, the <u>Township of Irvington</u> is the owner of certain tax sale certificates within the <u>Township of Irvington</u> and that are attached to many of these abandoned properties; and,
- **WHEREAS**, the <u>Township of Irvington</u> desires to make available for public sale said tax sale certificates in accordance with the New Jersey Abandoned Property Rehabilitation Act, specifically, N.J.S.A. 55:19-101, to facilitate the transfer of these abandoned properties to redevelopers with the expertise and experience to rehabilitate abandoned properties and return them to productive use;
- **NOW, THEREFORE, BE IT RESOLVED**, by the Municipal Council of the <u>Township of Irvington</u>, in the <u>County of Essex</u> State of New Jersey, as follows:
- **SECTION 1**. The Municipal Council hereby declares that the tax sale certificates should be sold in accordance with the appropriate statutes of the State of New Jersey and ordinances of the <u>Township of Irvington</u>.
- **SECTION 2.** The <u>Township of Irvington</u> via resolution number EDGO 18-0626-15 has authorized Max Spann Real Estate & Auction Co. (hereinafter "Auctioneer"), to offer for sale to the highest bidder by open public sale at an auction some or all of the properties on the list in Schedule A attached hereto and made a part hereof.
- **SECTION 3.** The public sale shall take place in the Township of Irvington, New Jersey on May 21, 2019 or as soon thereafter as the matter may be heard and publicly announced, provided the sale is not canceled.
- **SECTION 4**. The public sale, if not canceled, shall take place by open public sale at auction to the highest bidder.
- **SECTION 5**. All bidders at the time of sale must present a bank cashier's check, cash or money order in the amount of \$5,000.00, payable to themselves (to be endorsed to the <u>Township of Irvington</u>, or its designee if successful). SECTION 8. Acceptable bids shall be confirmed by resolution of the Municipal Council no later than the first regular meeting of the Municipal Council following the date of such sale.

SECTION 9. This resolution shall serve as authorization for the Township to have a public notice published in a newspaper circulating in the Township at least once during the two (2) consecutive weeks after the sale.

Resolution to declare May 2019 Mental Health Awareness Month and honor the
Irvington Counseling Center

WHEREAS, Mental illness affects both men and women, of all racial and ethnic groups; and

WHEREAS, Approximately 1 in 5 adults in the U.S. experience mental illness in a given year; and

WHEREAS, Suicide is the 10th leading cause of death in the U.S. and the 3rd leading cause of death in youth ages 10-24; and

WHEREAS, Nearly 60% of adults and 50% of youth aged 8-15 with a mental illness do not receive mental health services; and

WHEREAS, The Irvington Counseling Center, Inc. (ICC) is a non-profit agency supported by community, state, and federal funds enabling the dedicated staff to serve approximately 700 client contact visits per month. ICC has been providing a variety of mental health services to the residents of Irvington and surround community since 1961. It is their belief that all persons should be given every opportunity to receive therapeutic mental health services; and

WHEREAS, ICC collaborates with other local agencies, schools, hospitals, probation, parole, and courts to promote a condition of optimal mental health. Through outreach efforts the agency encourages and develops support throughout the community in order to increase the agency's scope of effectiveness and success rates. ICC provides case management, clinical treatment, and specialty services and employs a full time professional staff that includes Licenses Social Workers, Licensed Clinical Social Workers, and Staff Psychiatrists; and

WHEREAS, Over 900 Irvington residents, both children and adults, have accessed outpatient care from the Irvington Counseling Center in 2018 for mental health related conditions and is one of the few locations that accepts Medicaid, Medicare, and private insurance and greatly assists indigent clients;

WHEREAS, The Township of Irvington is committed to supporting the wellness of Irvington residents by educating them on the burden of mental health problems and have a responsibility to promote mental health wellness and support prevention efforts;

NOW, THEREFORE, BE IT RESOLVES that the month of May, 2019, be declared Mental Health Awareness Month in the Township of Irvington and call upon the citizens, government agencies, public and private institutions, businesses, and schools in Irvington to recommit our community to increasing awareness and understanding of mental health, the steps our citizens can take to protect their mental health, and the need for appropriate and accessible services for all people with mental health conditions. Additionally, the Township of Irvington would like to recognize the Irvington Counseling Center for the valuable services that they have continued to offer to the community for over 50 years.

AN ORDINANCE PROVIDING FOR THE VACATION OF ALL OF CRESCENT LANE AS LAID OUT ON THE IRVINGTON TAX MAP AND RESERVING TO THE TOWNSHIP OF IRVINGTON CERTAIN EASEMENT RIGHTS IN SAID STREET AND PLACING CERTAIN RESTRICTIONS AGAINST BUILDING STRUCTURES, ETC. IN SAID STREET

BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that:

SECTION 1. That all of Crescent Lane as laid out on the Irvington Tax Map shall be vacated as a public street or right of way, providing however, reserving unto the Township of Irvington and to the Public Service Electric and Gas Company, New Jersey American Water Company and such other public utilities as may have or require easements for the purpose of laying, relaying, rebuilding, reconstruction, or maintaining sewer, gas, electric, and water utilities and their pipes, manholes, inlets, and appurtenances now existing or in the future to be constructed in said street and reserving unto said public utilities their rights in certain easements heretofore granted; and providing further that the erection, construction, or placing of any building, vault, or structure which will interfere with the laying, relaying, rebuilding, reconstruction or maintenance of existing or additional sewer, gas, electric and water utilities and appurtenances are expressly prohibited and contrary to the purpose and provisions of this ordinance.

SECTION 2. The description listed below is made a part hereof and shall be placed on file in the office of the Township Engineer and shall be filed in the office of the Register of Essex County and such other office as required by statute.
