Hudley – Frederic 1. Relax Holiday Parking Restrictions for the 2019 Holiday Season

LATINO/HISPANIC HERITAGE MONTH-2019

WHEREAS, during the month of September and October, Latino residents of Irvington celebrate in honor of Latinos/Hispanic Heritage Month; and

WHEREAS, the Latino population of Irvington is growing and is rich in culture and heritage and the Township of Irvington is pleased to be able to honor those who play a large part in enhancing our community for the benefit of all; and

WHEREAS, the Latino people have made great contributions in the areas of architecture, sciences and in many other spheres of human enlightenment which are sources of advancements that make up America and the world today; and

WHEREAS, the nation's Latinos/Hispanic Heritage is more than five centuries old, its first official recognition did not occur until 1968. In that year both the House and Senate authorized an annual Proclamation designating the week of September 15th and 16th as Latinos/Hispanic Heritage Week which later was extended for a month by President Reagan; and

WHEREAS, "September 15 was chosen as the starting point for the celebration because it is the anniversary of independence of five Latin American countries: Costa Rica, El Salvador, Guatemala, Hondoras and Nicaragua. They all declared independence in 1821. In addition, Mexico, Chile and Belize celebrate their independence days on September 16, September 18 and September 21, respectively"; and

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that it hereby commemorates September 15, 2019 through October 15, 2019 as Latinos/Hispanic Heritage Month in the Township of Irvington and sends its congratulations and warmest regards to Irvington's Latino community; and

BE IT FURTHER RESOLVED that copies of this resolution be spread upon the minutes of the Irvington Municipal Council in recognition of our outstanding Latinos and community leaders.

Burgess – Hudley 3. Commemoration – Global Cat Day – October 16, 2019

GLOBAL CAT DAY 2019

WHEREAS, "Global Cat Day" is observed annually on October 16. Global Cat Day (2019) takes the place of National Feral Cat Day which was initiated by Alley Cat Allies in 2001; and

WHEREAS, in August of 2001, Alley Cat Allies celebrated their 10th anniversary, and launched the first annual Feral Cat Day to promote raising awareness about feral cat colonies and how to care for, and prevent them. Alley Cat Allies is a strong supporter of the 'Trap-Neuter-Return' policy, where stray cats are captured and brought in to local volunteer veterinarians to be neutered and returned to the streets. This allows the cats to live out their lives on the streets, without creating more kittens to perpetuate the problem; and

WHEREAS, Feral Cat Day is best celebrated by alerting people the various issues facing stray cats. Most cities currently catch and impound cats in shelters, briefly attempting to get them adopted before ultimately euthanizing them. Instead you can educate others about organizations like Alley Cat Allies, and the Trap-Neuter-Return policy that saves the cats lives while preventing future generations; and

WHEREAS, for many, feral cats are simply seen as a part of the community, and there's not much we can do to improve their lives. However, what many don't realize is that feral cats have an average of 1.4 litters each year, with an average of 3.5 kittens in each litter. That adds up to 420,000 kittens over seven years; and

WHEREAS, every year, nearly nine million dogs and cats are put down because the shelters can't find a home for them. By lowering the number of strays that are put in shelters in the first place, we can drastically cut back the number of animals that must be euthanized.

NOW THEREFORE BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that October 16, 2019 be designated as Global Cat Day in the Township of Irvington.

NOW THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON THE FOLLOWING:

- 1. The Township Attorney hired Camili Law LLC as a substitute prosecutor on an emergency basis for September 09 and 11, 2019 court sessions.

RESOLUTION TO ISSUE CHANGE ORDER NO.1 & FOR THE RESURFACING OF MADISON AVENUE, STUYVESANT AVENUE TO WASHINGTON AVENUE

WHEREAS, the Township of Irvington received a Grant from the New Jersey Department of Transportation (NJDOT) Transportation Trust Fund program in the amount of \$390,637.00 for the Resurfacing of Madison Avenue, from Stuyvesant Avenue to Washington Avenue; and

WHEREAS, in resolution DPW 16-0712-23, the Township engaged, the professional services of Keller & Kirkpatrick to prepare plans to be publicly bid for this project; and

WHEREAS, bids for this project were publicly advertised and three bids for this project were received and publicly read on April 13, 2017; and,

WHEREAS, based on the bids that were received for this project, the bid of J.A. Alexander, Inc. of Bloomfield, NJ at their bid price of \$ 245,944.31, was accepted as the lowest responsible bid for this project and a contract was awarded for this contract; and

WHEREAS, this project is now complete and the actual constructed quantities of the contract have reduced the price of this contract from the original bid price of \$245,944.31 to a final constructed price of \$239,109.89 for a reduction of -2.8% and the actual breakdown of the specifics of how this was achieved is detailed in a memorandum from the Township Engineer dated October 3, 2019.

NOW, THEREFORE, BE IT RESOLVED BY MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that a change order, Change Order No.1 & Final, for the construction of the Resurfacing of Madison Avenue be awarded to J.A. Alexander, Inc. of Bloomfield, NJ, reducing their completed construction cost to \$ 239,109.89 and that the Mayor is authorized to execute this change order on behalf of the Township.

BE IT FURTHER RESOLVED that pursuant to N.J.A.C. 5:34-5.2, a required Certificate of Availability of Funds No.C7-00220 for the above was obtained from the Chief Financial Officer of the Township of Irvington and the appropriation for this expenditure to be charged was in the amount of \$245,944.31 and was charged to Account No. G-02-xx-865-17A-001 however as this change order is less than the amount certified for this project, a new Certificate of Availability of Funds is not required for this action.

Resolution to Accept LEAD BASED PAINT HAZARD REDUCTION AND HEALTHY HOMES GRANT AWARD 2019-2020 Program Year

WHEREAS, the Department of Economic Development and Grants Oversight submitted a competitive grant application on behalf of the Township of Irvington to receive grant funds to implement Lead Based Paint Hazard Reduction and Healthy Homes programs in the Township of Irvington.

WHEREAS, the United States Department of Housing and Urban Development (HUD), Office of Lead Hazard Control and Healthy Homes (OLHCHH) has awarded a Fiscal Year 2019 - Lead Based Paint Hazard Reduction and Healthy Homes Grant in the amount of \$3,300,000.00 to the Township of Irvington, one of 77 state and municipal government recipients nationally, for the fiscal year October 1, 2019 to September 30, 2020 to make local housing safer and healthier.

WHEREAS, the Lead Based Paint Hazard Reduction and Healthy Homes Grants are national grants awarded to successful state and local applicants to implement lead hazard housing rehabilitation to protect children and families from lead-based paint and home health; and

BE IT FURTHER RESOLVED that the Mayor of the Township of Irvington hereby accepts this grant award from the United States Department of Housing and Urban Development (HUD), Office of Lead Hazard Control and Healthy Homes (OLHCHH) in the amount of Three Million, Three Hundred Thousand Dollars (\$3,300,000.00) to implement Lead Based Paint Hazard Reduction and Healthy Homes programs.

RESOLUTION OF THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON

WHEREAS, New Cingular Wireless PCS, LLC ("AT&T") is a provider of commercial Mobile Service subject to regulation by the Federal Communications Commission; and

WHEREAS, AT&T has entered into agreements with parties that have the lawful right to maintain poles in the public right-of-way pursuant to which AT&T may use such poles erected within the public right-of-way in the Township of Irvington; and

WHEREAS, New Jersey law permits such use provided that there is the consent of the relevant municipality;

NOW THEREFORE BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON, COUNTY OF ESSEX, STATE OF NEW JERSEY THAT:

- 1. Permission and authority are hereby granted to AT&T and its successors and assigns, to use poles erected by parties that have the lawful right to maintain poles within the public right-of-way in the Township of Irvington, subject to the following:
- A. AT&T, and its successors and assigns, shall adhere to all applicable Federal, State, and Local laws regarding safety requirements related to the use of the public right-of-way.
- B. AT&T, and its successors and assigns, shall comply with all applicable Federal, State, and Local laws requiring permits prior to beginning construction, and shall obtain any applicable permits that may be required by the Township of Irvington.
- C. Such permission be and is hereby given upon the condition and provision that AT&T, and its successors and assigns, shall indemnify, defend and hold harmless the Township of Irvington, its officers, agents, and servants, from any claim of liability or loss or bodily injury or property damage resulting from or arising out of the acts or omissions of AT&T or its agents in connection with the use and occupancy poles located within the public right-of-way, except to the extent resulting from the acts or omissions of the Township of Irvington.
- D. AT&T shall, at its own cost and expense, maintain commercial general liability insurance with limits not less than \$1,000,000 for injury to or death of one or more persons in any one occurrence and \$500,000 for damage or destruction to property in any one occurrence. AT&T shall include the Township of Irvington as an additional insured. AT&T may meet all or a portion of this insurance coverage and limit requirement by self-insurance so long as it provides evidence demonstrating its financial ability to meet the insurance coverage and limit requirement. If AT&T elects to self-insure, it is not required to name additional insureds under this section.
- E. AT&T shall be responsible for the repair of any damage to paving, existing utility lines, or any surface or subsurface installations, arising from its construction, installation or maintenance of its facilities.
- F. Notwithstanding any provision contained herein, neither the Township of Irvington nor AT&T shall be liable to the other for consequential, incidental, exemplary, or punitive damages on account of any activity pursuant to this instrument.
- G. This instrument shall be adopted on behalf of the Township of Irvington by the Municipal

Council of the Township of Irvington and attested to by the Township of Irvington Clerk who shall affix the Township of Irvington Seal thereto.

H. The permission and authority hereby granted shall continue for the same period of time as the grant to parties whose poles AT&T is using.

STATEMENT
