AUTHORIZING A CHANGE ORDER FOR 2018 SUMMER FOODS PROGRAM SERVICES

WHEREAS, a contract was awarded to Karson Food Service, by resolution number DPR 18-0612-2, in the amount of \$124,626.00 for 2018 summer foods program service; and

WHEREAS, the Recreation Director and Summer Foods Service Director would like to increase this service contract as a result of six additional sites being added to the summer foods schedule, Saturdays feedings at Irvington Park and overall increase in the number of children attending the summer programs; and

WHEREAS, this additional request will increase the service contract by \$1,867.30.

NOW THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that an additional \$1,867.30 will be paid to Karson Food Service Inc., 3409 Rose Ave, Ocean, NJ 07712 for Summer Foods Program Service; and

THEREFORE, BE IT RESOLVED, that the Mayor be and is hereby authorized to execute Change Order #1 with Karson Food Service Inc., 3409 Rose Ave, Ocean, NJ 07712 for Summer Foods Program Service, increasing the total contract to \$126,626.85. An overall increase of \$1,867.30; and

BE IT RESOLVED, that the required certification of availability of funds C8-00328 in the amount of \$1,867.30 from account number G-02-xx-714-18A-299 has been obtained from the Chief Financial Officer.
