AWARD A CONSTRUCTION CONTRACT FOR THE REMOVAL AND REPLACEMENT OF THE COIT STREET SALT DOME

WHEREAS, the Department of Public Works of the Township of Irvington has owned and operated a salt storage facility within the Department of Public Works Coit Street Garage, located at 406 Coit Street; and

WHEREAS, this salt storage is an integral part of the Township's ability to conduct snow removal and salting operations within the Township; and

WHEREAS, the existing salt storage facility, while having performed adequately for many years, has outlived its useful life and is beyond the point of repair so that demolition of the existing facility is necessary and construction of a new facility is required; and,

WHEREAS, after publicly advertising and publicly receiving bids, bids were received from three contractors for this project; and

WHEREAS, based upon a review of the bid documents, it was determined that the lowest responsible bid for this project was the bid of IBN Construction Corporation of Newark, New Jersey at the bid price of \$ 385,000.00.

NOW, THEREFORE, BE IT RESOLVED BY MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that a contract in the amount of \$ 385, 0000.00 be awarded to IBN Construction Corporation of Newark, New Jersey for the Removal and Replacement of the Coit Street Salt Dome project.

BE IT FURTHER RESOLVED that pursuant to N.J.A.C. 5:34-5.2, the required Certificate of Availability of Funds No. C9-00192 for the above has been obtained from the Chief Financial Officer of the Township of Irvington and the appropriation to be charged for this expenditure is in the amount of \$385,000.000 is Account No. C-04-56-852-019-905.
