CONTRACT EXTENSION FOR PEST CONTROL AND MANAGEMENT SERVICES

WHEREAS, resolution number DH 17-0215-3 authorized a contract for pest control and management services which expires on February 15, 2018; and

WHEREAS, resolution number DH 18-0313-6 extended this service contract for one year until February 15, 2019; and

WHEREAS, the original specifications included language that allowed for the extension of this contract for [two] one year contract at the existing terms and conditions if mutually accepted to the vendor and Township; and

WHEREAS, the vendor has agreed to extend the existing agreement for one month; and

WHEREAS, it would be in the Township's best interest to extend the existing agreement for one month as recommended by the Health Director; and

NOW, BE IT HEREBY RESOLVED by the Township of Irvington, Essex County, New Jersey that the following contract be extended for one month, starting on February 15, 2019 until March 18, 2019 with TRI-County Termite and Pest Control, 187 Delaware Ave, Carneys, NJ 08069 for an amount not to exceed \$1,000.00; and

BE IT FURTHER RESOLVED, that the required certification of availability of funds C9-00193 in the amount of \$1,000.00 from account number T-21-41-850-19D-804 has been obtained from the Chief Financial Officer; and

BE IT FURTHER RESOLVED that the Township Attorney is directed to prepare the appropriate contracts and the Mayor and the Township Clerk be and the same are hereby authorized to execute said contract with the above listed company.


