WHEREAS, as history is filled with the far reaching accomplishments and contributions of Caribbean Americans, the Township of Irvington in partnership with the Caribbean American Heritage and Cultural Foundation of New Jersey, Inc. would like to present the Business Champion Award to **Antojitos Restaurant**, a long standing business in the Township of Irvington;

WHEREAS, as a result of the far reaching accomplishments and contributions of Caribbean Americans, in June 2005, the House of Representatives unanimously adopted H. Con. Res. 71, sponsored by Congresswoman Barbara Lee, recognizing the significance of Caribbean people and their descendants in the history and culture of the United States. On February 14, 2006, the resolution similarly passed the Senate, culminating a two-year, bipartisan and bicameral effort;

WHEREAS, this year marks the thirteenth anniversary of June as National Caribbean American Heritage Month;

WHEREAS, the Township of Irvington is home to and employer of many Caribbean Americans;

WHEREAS, to commemorate and celebrate Caribbean Heritage Month, the Township of Irvington is hosting a heritage month Flag Raising Ceremony on May 31, 2019 and a Caribbean Festival on June 22, 2019;

WHEREAS, at the Flag Raising Ceremony on May 31st, the Township wishes to commend, **Antojitos Restaurant**, for being a leader in Irvington's business community;

WHEREAS, the Township of Irvington would also like to commend **Antojitos Restaurant** for its support of community activities in the Township of Irvington; and

NOW, THEREFORE, Mayor Tony Vauss and the Township of Irvington Municipal Council hereby commends **Antojitos Restaurant** for their professional and philanthropic minded contributions to the residents of the Township of Irvington ; and,
