## AUTHORIZING A NON-FAIR AND OPEN FOR HEALTH PRESCRIPTION CLAIMS SERVICES

WHEREAS, the Township of Irvington, in the County of Essex and State of New Jersey, is in need of health prescription claims services; and

WHEREAS, the Township would like to retain the service of CVS Pharmacy to process health prescription claims for the Township; and

WHEREAS, CVS Pharmacy has provide the Township with a proposal to provide this service for a total sum of \$4,511,626.76 for one year; and

WHEREAS, pursuant to the provisions of N.J.S.A. 19:44A-20.4 the vendor has completed the required pay to plays forms; and

WHEREAS, the C-271 Political Contribution Disclosure forms were on file in the Office of the Municipal Clerk and Purchasing Agent on September 08, 2019 ; and

WHEREAS, the Township would like to award a Non Fair and Open contract to CVS Pharmacy, 1 CVS Drive, Woonsocket, RI 02895; and

WHEREAS, the term of this contract will expire on October 09, 2020; and

WHEREAS, CVS pharmacy has completed and submitted a Business Entity Disclosure Certification which certifies that the organization has not made any reportable contributions to a political or candidate committee in the Township of Irvington in the previous one year, and that the contract will prohibit CVS Pharmacy from making any reportable contributions through the term of the contract, and

NOW THEREFORE, BE IT RESOLVED that the Municipal Council of the Township of Irvington authorizes the award of a non-fair and open contract to CVS Pharmacy, 1 CVS Drive, Woonsocket, RI 02895; and,

BE IT FURTHER RESOLVED, that the required certification of availability of funds C9-00294 in the amount of \$4,511,626.76 from account number T-15-56-286-001-000 has been obtained from the Chief Financial Officer.

BE IT FURTHER RESOLVED that the Township Attorney is hereby authorized and directed to prepare the necessary contract, and the Mayor and Township Clerk are authorized and directed to sign the same; and

BE IT FURTHER RESOLVED, notice of this action shall be published in newspapers as required by law by the Municipal Clerk.
