AUTHORIZING PURCHASES UNDER THE STATE OF NEW JERSEY COOPERATIVE PURCHASING PROGRAM OVER THE BID THRESHOLD OF \$40,000.00

WHEREAS, the Township of Irvington, pursuant to N.J.S.A. 40A:11-12(a) and N.J.A.C. 5:34-7.29(c) may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury; and,

WHEREAS, the Police Department would like to purchase wireless equipment and devices from AT&T First Net Solution under State contract number 82584/T216A; and

WHEREAS, the Police Department will enter into a Trial period to test the device and service starting on October 15, 2019 until November 15, 2019 to determine if the cellular phones and service meets the Township's needs ; and

WHEREAS, after November 15, 2019 until February 29, 2020 if the telephone device and services meets the Township needs then the Township of Irvington intends to enter into contract with AT&T First Net Solution over the bid threshold of \$40,000.00 through this resolution and properly executed purchase orders, which shall be subject to all the conditions applicable to current State contracts.

NOW, THEREFORE, BE IT RESOLVED that the Township Council of the Township of Irvington authorizes the purchase of telephone equipment and service from AT&T First Net Solution, One AT&T Way, Room 2C224E, Bedminster, NJ 07921 over the bid threshold of \$40,000.00, pursuant to all the conditions of the individual State contracts; and

BE IT FURTHER RESOLVED by the Township Council that, pursuant to the N.J.A.C. 5:30-5.5(b), the certification of available funds and resolutions shall be certified at such time as the goods or services are called for prior to placing the order for good or service in excess of \$40,000.00, and a certification of availability of funds is made by the Chief Financial Officer via an authorized purchase order; and

BE IT FURTHER RESOLVED that the duration of this authorization shall be until February 29, 2020 when the State Contract expires.

BE IT FURTHER RESOLVED, that this contract shall not exceed \$200,000.00.

BE IT FURTHER RESOLVED a separate resolution will be submitted to the Municipal Council for all addition vendors exceeding the bid threshold of \$40,000.00.
