WHEREAS, the Recreation department wishes to renovate the parkway playground area at Berkeley Field, and;

WHEREAS, the Recreation Director has obtained two quotes for this service from Ditomaso Landscape Group and Downes Tree Services, herein attached.

WHEREAS, this service will exceed the Pay to Play Threshold of \$17,500.00, and;

WHEREAS, the Downes Tree Services has provided the lowest quote for this service, and;

WHEREAS, pursuant to the provisions of N.J.S.A. 19:44A-20.4 the vendor has completed the required pay to plays forms; and

WHEREAS, the C-271 Political Contribution Disclosure forms were on file in the Office of the Municipal Clerk and Purchasing Agent on September 20, 2019; and

NOW THEREFORE, BE IT RESOLVED that the Municipal Council of the Township of Irvington authorizes the award of a contract to Downes Tree Service of 65 Royal Ave, Hawthorne, NJ 07506 in the amount of \$39,850.00 to renovate the parkway playground at Berkeley Field; and,

BE IT FUTHER RESLOVED that the required certification of availability of funds C9-00287 in the amount of \$39,850.00 from account number C-04-56-852-019-911 has been obtained from the Chief Financial Officer.
