WHEREAS, N.J.S.A. 39:4-197.5 provides that a Municipality may by resolution provide for restricted parking space(s) in front of residences for use by any person who has been issued a special vehicle identification card pursuant to the provisions of N.J.S.A. 39:4-205, when using a motor vehicle on which is displayed a certificate, for which a special vehicle identification card has been issued pursuant to N.J.S.A. 39:4-206; and

WHEREAS, a restricted handicapped parking space has been previously established at 152 Madison Avenue, 166 Laurel Avenue, 432 South 21st Street, 25 Sanford Terrace and 33 Temple Place; and

WHEREAS, the Police Department has determined that the handicapped resident for which the restricted handicapped parking space in front of 152 Madison Avenue, 166 Laurel Avenue, 432 South 21st Street, 25 Sanford Terrace and 33 Temple Place have relocated and will no longer reside at that address and that there is no longer any need to for the restricted handicapped parking space in front of 152 Madison Avenue, 166 Laurel Avenue, 432 South 21st Street, 25 Sanford Terrace and 33 Temple Place:

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that the restricted handicapped parking space heretofore established in front of 152 Madison Avenue, 166 Laurel Avenue, 432 South 21st Street, 25 Sanford Terrace and 33 Temple Place be and the same is hereby rescinded; and

BE IT FURTHER RESOLVED that the Department of Public Works is directed to remove the restricted handicapped parking sign located in front of 152 Madison Avenue, 166 Laurel Avenue, 432 South 21st Street, 25 Sanford Terrace and 33 Temple Place.
