WHEREAS, the United States Congress authorized the Defense Logistics Agency (DLA) Law Enforcement Support Office (LESO) 1033 Program to make use of excess Department of Defense personal property by making that personal property available to municipal, county and State law enforcement agencies (LEAs); and

WHEREAS, DLA rules mandate that all equipment acquired through the 1033 Program remain under the control of the requesting LEA; and

WHEREAS, participation in the 1033 Program allows municipal and county LEAs to obtain property they might not otherwise be able to afford in order to enhance community preparedness, response, and resiliency; and

WHEREAS, although property is provided through the 1033 Program at no cost to municipal and county LEAs, these entities are responsible for the costs associated with delivery, maintenance, fueling, and upkeep of the property, and for specialized training on the operation of any acquired property; and

WHEREAS, NJ.S.A. 40A:5-30.2 requires that the governing body of the municipality or county approve, by a majority of the full membership, both enrollment in, and the acquisition of any property through, the 1033 Program; and

NOW THEREFORE BE IT FURTHER RESOLVED that Irvington Police Department is hereby authorized to acquire the following "DEMIL B through Q" property, if it shall become available in the period of time for which this resolution authorizes: (1) utility truck, (5) 5.56 millimeter rifles, binoculars, medical and first aid equipment and supplies, personal protection equipment, (1) MRAP, rifle lockers or safe, and

BE IT FURTHER RESOLVED that the Irvington Police Department shall develop and implement a full training plan and policy for the maintenance and use of the acquired property; and

BE IT FURTHER RESOLVED that the Irvington Police Department shall provide a quarterly accounting of all property obtained through the 1033 Program which shall be available to the public upon request; and

WHEREAS, the Municipal Council of the Township of Irvington wishes to acknowledge the 2020 Valor Awards – Irvington Fire Division Recipients: Firefighter Javier Rodriguez and Firefighter Ashanti Wilkerson for their professional achievements, bravery and perseverance in risking their own lives in a honorable way to save the lives of others; and

WHEREAS, Fire Incident 1 - Deputy 41 responded to 60 Maple Avenue for a reported structure fire. Upon arrival, Deputy 41 found an occupied 3 story wood frame with fire showing on division 2. Deputy 41 established command and a signal 11 was called; and

WHEREAS, E42 stretched a line to division 2 for fire suppression. E41 stretched a backup line to division 2 to assist with extinguishment. Firefighter Rodriguez performed a primary of division 1 and removed a sleeping eleven year old male from the building. E44 assisted E42 with water supply then proceeded to division 3 to check for extension, none found. L42

split their crew and performed primary searches of divisions 2 and 3. L41 split their crew with crew one checking for extension in the D exposure (none found) and crew two laddering the roof and opening the scuttle to check for extension, none found. The blitz fire was set up in the alley between the fire building and exposure D as a precaution. At this time, the main body of fire was knocked down and a signal 100 was called. PARS was performed with all accounted for. All crews assisted with overhaul, rotating in Maplewood E32 and Newark Ladder company. The utilities were shut off inside the building by Ladder 41 crew. Crews performed secondary searches of all divisions (negative). The fire was extinguished and crews repacked their hose. PS electric and gas on the scene to cut utilities at the street. Command was transferred to E42 to await the arrival of the fire inspector and Red Cross; and

WHEREAS, Act. Lt. Griffin #173 was treated at the scene for a minor face laceration by EMS.

WHEREAS, Fire Incident 2 - Engine 44, Ladder 42, Deputy 1 dispatched to Garden State Parkway for vehicle with people in them trapped due to flash flooding. On arrival found Garden State Parkway was unpassable on both North and South between exits 143c and 144 due to flooding. One vehicle stalled out in water on Parkway South, three vehicles stalled out in water on Parkway North; and

WHEREAS, Engine 44 approached all vehicles to confirm there was no medical conditions that needed immediate attention. State Police was notified of Garden State Parkway's condition. Engine 44, Ladder 42 were able to push vehicle to the side of the road on Parkway South side and two of three vehicles on parkway North side. Water began to subside and traffic was able to proceed on both North and South side. Command was transferred to State Police; and

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON that each one of these heroic officers are being honored for the good they have done and for their heroic actions, in the name of everyone they have saved, of their families and friends, for putting their lives at risk for someone else and for placing others before themselves.

RESOLUTION OF COMMENDATION IRVINGTON CHAMBER OF COMMERCE VALOR AWARDS – IRVINGTON PUBLIC SAFETY DEPARTMENT - POLICE DIVISION MARCH 26, 2020

WHEREAS, the Municipal Council of the Township of Irvington wishes to acknowledge the 2020 Valor Awards – Irvington Police Division Recipients: Detective Sergeant Brandis Puryear,

Detective Sergeant Maurice Taylor, Detective Pamela Mays, Detective Ronessa Youngblood, Police Officer Samuel Addo, Special Law Enforcement Officer Brandon Gaeta, Police Officer Bao Ho, Police Officer Tahi Jackson and Police Officer Amari Ricketts for their professional achievements, bravery and perseverance in risking their own lives in a honorable way to save the lives of others; and

WHEREAS, on Thursday, August 8, 2019 at 1128 hours Irvington Police Officers were dispatched to the area of 388 Myrtle Avenue on the reports of shots fired and a man down. Officer Addo and Officer Jackson were in the area on an unrelated job and were the nearest units to the scene. Detective Sergeant Taylor, Detective Sergeant Puryear, and Detective Mays were on Myrtle Avenue following up on an unrelated investigation and responded. Officer Gaeta, Detective Youngblood, Officer Ho and Officer Ricketts responded to assist. The Detectives were first on the scene and had located the victim. Enroute Officer Addo was stopped by a witness pointing to a person believed to be the suspect of the shooting. Officer Addo stopped him while Officer Ricketts arrived to assist; and

WHEREAS, Officer Gaeta and Officer Jackson were driving to the scene when flagged down by a witness. The witness reported seeing the suspect walking on Myrtle Avenue and turn into a yard. Dispatch had radioed an update to responding units of a suspect wearing a white t-shirt, having a hairstyle of long dreadlocks walking northbound on Myrtle Avenue carrying a weapon. Officer Gaeta and Officer Jackson pulled up to where the witness had directed them and found they were near the Detectives and the victim of the shooting. Detective Youngblood and Officer Ho were responding and saw Officers Addo and Ricketts with the suspect they had stopped. Detective Youngblood and Officer Ho continued their search; and

WHEREAS, in the adjacent lot, Officer Gaeta and Officer Jackson had identified a suspect fitting the description. The suspect was behind a parked car, bending down in a manner they believed he was attempting to hide. Officer Jackson ordered the suspect to come out, the suspect raised up and holding a rifle at hip level fired in the direction of Officer Gaeta and Officer Jackson. Officer Gaeta was struck in the right heel and fell; Officer Jackson engaged the threat and returned fire in the direction of the suspect. The suspect turned, and while holding the rifle in one hand continued firing at police as he attempted to retreat. Officers radioed, "Shots fired, Officer down!"; and

WHEREAS, Detective Youngblood and Officer Ho had arrived and moved toward the shooting to assist. Officer Jackson was able to assist Officer Gaeta away from the threat to a nearby bush while Detective Youngblood and Officer Ho took a position of cover behind a marked police vehicle. Detective Youngblood and Officer Ho engaged the suspect drawing his attention from Officer Gaeta. Officer Jackson joined Detective Youngblood and Officer Ho. Officer Addo and Officer Ricketts heard the transmission on the radio and the gunfire responded from the south and flanked the suspect a few yards from the position of the other officers. Officer Addo and Officer Ricketts engaged the threat. At a point of the shootout, the suspect had donned a camouflage vest which was later found to be a ballistic vest (bulletproof); and

WHEREAS, Officer Gaeta, having sustained a gunshot to his heel continued to engage the threat while treating his wound by applying a tourniquet to his leg. Officer Gaeta was able to move from the bush to a nearby sidewalk where Detective Sergeant Puryear placed herself between the shooter and Officer Gaeta. Detective Mays remained near them for cover. Detective Sergeant Taylor engaged the shooting near the position of the other Officers and

Detectives. Detective Sergeant Taylor left to retrieve their vehicle. He backed to the sidewalk where Detective Sergeant Puryear and Officer Gaeta were lying. They moved Officer Gaeta to their car as the suspect turned his attention back to them firing in their direction. Detective Youngblood, Officer Ho and Officer Jackson fired drawing attention back to them as Officer Addo and Officer Ricketts held position south keeping the suspect from fleeing. As Detectives were moving to take Officer Gaeta from the threat Detective Sergeant Puryear was able to toss her remaining ammunition to Officer Ho. The Detectives transported Officer Gaeta to the regional trauma center at Rutgers University Hospital; and

WHEREAS, From each position Detective Youngblood, Officer Ho, Officer Jackson, Officer Addo and Officer Ricketts continued to address the threat and maintain control. Officer Ricketts said the suspect quickly moved from his position where he had been firing to the first alleyway south between two houses. Multiple units were on scene at this point holding the perimeter. As efforts were being coordinated and Officers closed in to further address the suspect he was discovered between the houses motionless. The suspect was arrested and the scene was secured. Once safe, Emergency Medical Service personnel were called to render aid; and

WHEREAS, as a result of the incident Officer Gaeta, Officer Jackson and Detective Youngblood sustained gunshot wounds. The suspect succumbed to his injuries. The shooting victim who police first arrived to help had also died. The entire incident from the first to the last shot lasted approximately 12 minutes. Officers moved toward the threat and engaged so others wouldn't be in danger. Under gunfire, Officers assisted their own removing Officer Gaeta from danger while others drew the gunfire in their direction. Using tactical training officers took positions surrounding the suspect in a manner keeping him contained and unable to move the imminent danger throughout the neighborhood. Officer Jackson and Detective Youngblood aware they had been grazed by bullets continued to engage the threat:

TOWNSHIP OF IRVINGTON CALENDAR YEAR 2020 MODEL ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

B. Ordinances on Second Reading

1. President Burgess: An ordinance amending graffiti will be heard at this time. The Assistant Clerk will read the notice of hearing.

AN ORDINANCE TO AMEND CHAPTER 342: PROHIBITING ACTS OF GRAFFITI IN THE TOWNSHIP OF IRVINGTON, REQUIRING NOTICE TO PROPERTY OWNERS TO REMOVE GRAFFITI AND PENALTIES FOR FAILURE TO DO SO.

An ordinance prohibiting acts of graffiti on buildings, structures and other exposed surfaces located within the Township, requiring the owner of a building, structure or other exposed surface located in the Township to remove graffiti and the penalties for failure to do so.

BE IT ORDAINED by the Municipal Council of the Township of Irvington as follows:

Section I. Definitions

Graffiti and/or an act of graffiti means any drawing, painting or making of any mark or inscription on public or private real or personal property without the prior written permission of the owner of the property.

Section II. Violations

A. No person shall purposely or knowingly vandalize, deface or otherwise damage the real or personal property of another by drawing, painting or otherwise inscribing, in any fashion, graffiti.

B. The act of graffiti shall constitute the willful, malicious or unlawful injury or destruction to real or personal property.

Section III. Notification of Order to Remove Graffiti to Property Owner

A. In the event graffiti is found, the Township shall provide the owner of record written notice of an order to remove said graffiti by certified mail and regular mail, which order shall afford the owner the opportunity to remove the graffiti within <u>90</u> days of the date that the notice is sent. However, the State Department of Transportation shall be afforded 120 days from the date that the notice is sent to remove graffiti from property owned by the Department.

B. The Township's order to remove shall contain a form to be utilized by a property owner to inform the Township that the graffiti has been removed and shall contain a certification stating that by affixing a signature to the form indicating that the graffiti has been removed, the owner is certifying that the facts set forth therein are true and that the certification shall be considered as if made under oath and subject to the same penalties as provided by law for perjury.

Section IV. Response to Order to Remove Graffiti from Property Owner

A property owner who has been ordered to remove graffiti shall respond to the Township by personal delivery or certified mail:

a) Any objection to the order, within 30 days of the date of the order;

b) Notice that the graffiti has been removed, within the time period set forth in the order, or in the case of the State Department of Transportation, within 120 days of the date of the order.

Section V. Objection to Order to Remove Graffiti

A property owner who objects to an order to remove graffiti may institute an action challenging the order before a court of competent jurisdiction within 60 days of the date of the order.

Section VII. Failure to Comply with Order to Remove Graffiti

A. Any person violating or failing to comply with any of the provisions of this chapter shall, upon conviction thereof, be punishable by a fine of not more than \$2,000, by imprisonment for a term not to exceed 90 days or by community service of not more than 90 days, or any combination of fine, imprisonment and community service as determined in the discretion of the Municipal Court Judge. The continuation of such violation for each successive day shall

constitute a separate offense, and the person or persons allowing or permitting the continuation of the violation may be punished as provided above for each separate offense.

B. If a property owner does not undertake the removal of graffiti within the time period set forth in the order, or in the case of the Department of Transportation, within 120 days of the date of the order, unless an action challenging the order to remove graffiti is still pending, the Township may remove the graffiti from that property and present the property owner with a detailed itemization of the costs incurred by the Township, by certified mail and regular mail, for reimbursement from the property owner.

C. Whenever the Township undertakes the removal of graffiti from any building, structure or other exposed surface, the Township, in addition to assessing the cost of removal as a municipal lien against the premises, may enforce the payment of such assessment, together with interest, as a debt of the owner of the property and may authorize the institution of an action at law for the collection thereof. The Superior Court shall have jurisdiction of any such action.

Section VIII. Severability

The provisions of this ordinance are declared to be severable, and if any section, subsection, sentence, clause or part thereof is, for any reason, held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity of any remaining sections, subsections, sentences, clauses or part of this ordinance.

Section IX. Repealed

All prior ordinances or parts of ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

Section X. Effective Date

This ordinance shall take effect immediately upon adoption and publication according to law.

A. Any person violating or failing to comply with any of the provisions of this chapter shall, upon conviction thereof, be punishable by a fine of not more than \$2,000, by imprisonment for a term not to exceed 90 days or by community service of not more than 90 days, or any combination of fine, imprisonment and community service as determined in the discretion of the Municipal Court Judge. The continuation of such violation for each successive day shall constitute a separate offense, and the person or persons allowing or permitting the continuation of the violation may be punished as provided above for each separate offense.

B. The violation of any provision of this chapter shall be subject to abatement summarily by a restraining order or injunction issued by a court of competent jurisdiction.

Vick – Cox 21. Authorize Issuance of Not To Exceed \$12,500,000.00 in Tax Anticipation Notes of Calendar Year 2020

AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$12,500,000 TAX ANTICIPATION NOTES OF CY 2020 OF THE TOWNSHIP OF IRVINGTON, IN THE COUNTY OF ESSEX, NEW JERSEY.

BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF IRVINGTON, IN THE COUNTY OF ESSEX, NEW JERSEY (not less than the majority of the full membership of the governing body) AS FOLLOWS:

Section 1. In anticipation of the collection of taxes during the current fiscal year, we are hereby authorized to be issued tax anticipation notes of the Township, each to be known as "Tax Anticipation Note of CY-2020," in amounts not exceeding \$12,500,000.00. The proceeds of such notes shall be applied only to purposes provided for in the budget or for which taxes are levied for the current year.

Section 2. The following certificate has been prepared by the Chief Financial Officer and is filed in the office of the Township Clerk:

CERTIFICATE WITH RESPECT TO TAX ANTICIPATION NOTES

I, Faheem J. Ra'Oof, Chief Financial Officer of the Township of Irvington, in the County of Essex, New Jersey HEREBY CERTIFY as follows:

1. The gross borrowing power in respect to tax anticipation notes for the calendar fiscal year of 2020, being 30 percent of the tax levy for all purposes of the calendar fiscal year of 2019, plus 30 percent of the amount of miscellaneous revenues realized in cash during the calendar fiscal year of 2019, is \$44,270,165.20.

2. The amount of notes outstanding in anticipation of the collection of taxes of the calendar fiscal year of 2019, except such notes as will be renewed by or paid from the proceeds of the notes to be issued, is \$ -0-.

3. The net borrowing power, being the excess of the first over the second of the two above amounts, is \$44,270,165.20.

4. This certificate is made with respect to \$12,500,000.00 Tax Anticipation Notes of CY-2019 about to be authorized by the Township Council of the Township of Irvington.

Section 3. The following matters in connection with the notes are hereby determined:

(a) All notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer, provided that no note shall mature later than 120 days following the end of the calendar fiscal year.

(b) All notes issued hereunder shall bear interest at such rate or rates as may be determined by the Chief Financial Officer.

(c) All notes shall be in the form prescribed by the Local Budget Law and otherwise as determined by the Chief Financial Officer and such officer's signature upon the notes shall be conclusive as to such determination;

(d) Notes issued hereunder may be renewed from time to time, provided, however, that no renewal note shall be issued later than the last day of the fiscal year.

(e) All notes shall be executed by the Mayor and the Chief Financial Officer and attested by the Township Clerk.

Section 4. The Chief Financial Officer is authorized and directed to determine all matters in connection with the notes not determined by this or by a subsequent resolution and such officer's signature upon the notes shall be conclusive as to such determination.

Section 5. The Chief Financial Officer is hereby authorized to sell the notes from time to time at public or private sale in such amounts as such officer may determine at not less than par and to deliver them from time to time to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof and payment therefore.

Section 6. Any instrument issued pursuant to this resolution shall be a general obligation of the Township, and the full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations.

Section 7. The Chief Financial Officer is authorized and is directed to report in writing to the Township Council at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this resolution is made, such report to include the amount, the description, the interest rate and the maturity of the notes sold, the price obtained and the name of the purchaser.

Section 8. The Chief Financial Officer, in connection with other professionals of the Township acting under his direction, is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document for the Township, as it may be so updated from time to time, to be distributed in connection with the sale of obligations of the Township. The Chief Financial Officer is hereby authorized to execute such disclosure document on behalf of the Township.

Section 9. (a) Solely for purposes of complying with Rule 15c2-12 of the Securities and Exchange Commission (the "Rule"), and provided that an issue of notes authorized by this resolution is not exempt from the Rule and provided that an issue of notes is not exempt from the following requirements in accordance with paragraph (d) of the Rule, for so long as an issue of notes of the Issuer remains outstanding (other than an issue of notes which has been wholly defeased), the Township shall provide in a timely manner to each nationally recognized municipal securities information repository ("National Repositories") or to the Municipal Securities Rulemaking Board, and to the appropriate State information depository, if any, ("State Depository," and together with the National Repositories, the "Repositories") notice of the following events with respect to an issue of notes, if material (herein "Material Events"):

- (1) Principal and interest payment delinquencies;
- (2) Non-payment related defaults;
- (3) Unscheduled draws on debt service reserves reflecting financial difficulties;
- (4) Unscheduled draws on credit enhancements reflecting financial difficulties;
- (5) Substitution of credit or liquidity providers, or their failure to perform;
- (6) Adverse tax opinions or events affecting the tax-exempt status of the security;
- (7) Modifications to rights of security holders;

- (8) Bond calls;
- (9) Defeasances;
- (10) Release, substitution, or sale of property securing repayment of the securities; and
- (11) Rating changes.

(b) The covenants and undertakings contained in this Section are made for the benefit of the holders or beneficial owners of the notes issued under this resolution.

(c) The Chief Financial Officer shall determine, in consultation with Bond Counsel, the application of the Rule or the exemption from the Rule for each issue of notes prior to their offering. Such officer is hereby authorized to enter into written contracts or undertaking to implement this resolution and is further authorized to amend such contracts or undertakings as needed to comply with the Rule or upon the advice of Bond Counsel.

(d) In the event that the Township fails to comply with this resolution or the written contract or undertaking, the Township shall not be liable for monetary damages, remedy of the holders or beneficial owners of the notes being hereby specifically limited to specific performance of the covenants contained in this resolution or the written contract or undertaking.

Section 10. This resolution shall take effect immediately.
