PROPOSED 2021 CAMPTOWN BID BUDGET

(final approval by CBID Board of Directors at July 29, 2021 Annual Membership Meeting)

2021 Budget Overview:

This year's budget maintains the reduced CBID tax assessment rate, from 5% (2000-12) to 3% (2013-16) to 2.5% since 2017 to provide relief to CBID taxpayers by utilizing \$110,056 of our carryover fund balance. The 2021 CBID budget continues funding the daily cleaning/maintenance of the CBID, electricity for more than 30 floodlights throughout the CBID, and our matching property improvement grant program. We are adding two new projects in 2021: a "Graffiti Removal Pilot Project" to remove 2000 SF of graffiti and coat 1000 SF of the cleaned surfaces in the CBID, and our "Security Camera Pilot Project" that is installing 20 exterior cameras in five locations in the CBID while offering \$25,000 in matching grants to members who wish to install separate cameras. Meanwhile, marketing, administration & operations line items remain the same as in past years.
