AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 620, ARTICLE XX, SECTION 17 OF THE REVISED CODE OF THE TOWNSHIP OF IRVINGTON REGARDING PARKING RESTRICTED FOR RESIDENTS; PARKING PERMIT REQIRED; FEE.

BE IT ORDAINED BY TO MUNICIPAL COUNCIL OF THE TOWNSHIP OF IRVINGTON as follows:

SECTION 1. Section 620-17 of the Revised Code of the Township of Irvington is hereby amended as supplemented to read in its entirety as follows:

§ 620-17 Parking restricted for residents; parking permit required; fee. [Added 9-25-2001 by Ord. No. MC 3178]

- A. No person shall park a vehicle between the hours and days specified in Schedule VA (§ **620-99**) upon any of the streets or parts of streets described in said Schedule VA, attached to and made a part of this chapter, unless said person is a resident of the street.
- B. Residents' vehicles must receive and display a parking permit provided by the Township of Irvington.
- C. Vehicles parked in violation of this section shall be subject to towing, and the vehicle owners shall be subject to the fines set forth in § **620-4B**.
- D. Fees and limitation on permits. [Added 6-23-2015 by Ord. No. MC 3540]

- (1) There is a fee of \$35 per year with a limit of two parking permits, and any request beyond two is \$50 per permit with a limit of two.
- (2) There shall be no more than four permits per household.
- E. Any owner of a corner property at an intersection of a resident-only parking street shall be entitled to receive one parking permit from the Township. The owner must apply for and submit all necessary paperwork and applicable fees in order to receive such parking permit. The right to obtain a parking permit does not extend to the tenant/leasee of a corner property. It rests solely with the deeded owner(s) of the property. [Added 5-17-2016 by Ord. No. MC 3570]
- F. To receive a parking permit each vehicle shall be registered and insured at the Irvington address claimed by the applicant as establishing residency. Failure to produce this information shall result in an automatic rejection of the application.
- SECTION 2. All ordinances or parts thereof that are inconsistent herewith are hereby repealed.

SECTION 3. This ordinance shall take effect upon final passage and publication according to law.

NEW APPLICATION FEE: \$50.00 submitted with the application. Approved permits are valid from twelve (12) months from the date of permit issuance.

RENEWAL APPLICATION FEE: \$25.00 submitted with the application. Applications for renewal must be submitted one hundred and twenty (120) days prior to the expiration of the permit. Failure to reapply shall result in the forfeiture of assigned parking.

RELOCATION FEE: All changes of address will require submission of a new application and \$50.00.

REPLACEMENT OF A PERMIT: \$25.00 to replace a permit that has been lost or destroyed.

SECTION 2. All ordinances or parts thereof that are inconsistent herewith are hereby repealed.

SECTION 3. This ordinance shall take effect upon final passage and publication according to law.

ORDINANCE APPROPRIATING \$250,000 FROM THE GENERAL CAPITAL SURPLUS FUND FOR VARIOUS SEWER SYSTEM AND STORM WATER IMPROVEMENTS IN AND BY THE TOWNSHIP OF IRVINGTON, IN THE COUNTY OF ESSEX, NEW JERSEY.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF IRVINGTON, IN THE COUNTY OF ESSEX, NEW JERSEY AS FOLLOWS:

Section 1. The Township of Irvington, in the County of Essex, New Jersey (the "Township") hereby appropriates \$250,000 from the General Capital Surplus Fund for various sewer system and storm water improvements, including a sewer system capital needs assessment and storm water improvements, including South 20th Street, mapping of the sewer system and the deployment of Lenox Avenue devices, including all related costs and expenditures incidental thereto.

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended

to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.
