WHEREAS, on or about September 20, 2022, the Director, Division of Taxation, Department of the Treasury, certified the Table of Equalized Valuations for the tax year 2022 to the State Commissioner of Education for use in the determination of the amount of State school aid for the school year under N.J.S.A. 54:1-35.1, et seq; and

WHEREAS, the ratio of assessed valuation to true value of real property for the Township of Irvington contained in the Table of Equalized Valuations is 61.31%; and

WHEREAS, the Township of Irvington, through its Tax Appeals Counsel, Inglesino, Webster, Wyciskala & Taylor, LLC, filed a complaint with the Tax Court of New Jersey; and

WHEREAS, the complaint challenged forty-five (45) sales that should not have been included in determining the Township of Irvington ratio of assessed valuation to true value of real property, pursuant to N.J.S.A. 54:1-35.1 et seq. and N.J.A.C. 18:12-1.1.;

WHEREAS, the improper inclusion of said sales resulted in an incorrect ratio of assessed valuation to true value of real property for the Township of Irvington; and WHEREAS, the parties thereafter engaged in discovery and settlement negotiations; and

WHEREAS, as a result of said discovery and settlement negotiations, the Director of the Division of Taxation has agreed that thirty-three (33) of the challenged sales should be excluded from the Township of Irvington's ratio of assessed valuation to true value of real property; and

WHEREAS, by excluding the agreed upon sales, the Township of Irvington's ratio of assessed valuation to true value contained in the Table of Equalized Valuations for the tax year 2022 has increased from 61.31% to 62.44%; and

WHEREAS, as a result of said discovery and settlement negotiations, the Township of Irvington's Tax Appeals Counsel and Municipal Tax Assessor recommend that the remaining twelve (12) challenged sales should not be excluded from the Township of Irvington's ratio of assessed valuation to true value of real property and should be withdrawn from the Complaint; and

WHEREAS, the Tax Appeals Counsel, Township Attorney and the Municipal Tax Assessor all recommend said settlement to the Township Council; and

WHEREAS, the Township Council is of the opinion that said settlement is in the best interests of the Township of Irvington;

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHP OF IRVINGTON that the settlement in this matter as set forth herein above, be and the same is approved; and
