# ORDINANCE OF THE TOWNSHIP OF IRVINGTON, IN THE COUNTY OF ESSEX, AUTHORIZING THE EXECUTION OF A FINANCIAL AGREEMENT WITH 530 CHANCELLOR URBAN RENEWAL LLC, AND GRANTING A TAX EXEMPTION WITH RESPECT TO CERTAIN PROPERTY IDENTIFIED ON THE TOWNSHIP'S TAX MAP AS BLOCK 187, LOTS 2.01 AND 2.02 AND IDENTIFIED IN THE CITY TAX RECORDS AS 508-534 CHANCELLOR AVENUE, IRVINGTON, NEW JERSEY

**WHEREAS**, the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1 *et seq.*, as amended and supplemented (the "**Redevelopment Law**"), authorizes municipalities to determine whether certain parcels of land in the municipality constitute areas in need of rehabilitation or redevelopment; and

WHEREAS, the Municipal Council (the "Township Council") of the Township of Irvington (the "Township"), by Resolution 94-0809-5 dated August 9, 1994, created the Township Urban Enterprise Zone (the "UEZ") pursuant to the New Jersey Urban Enterprise Zones Act, N.J.S.A. 52:27H-60 et seq. (the "UEZ Act"); and

**WHEREAS**, in accordance with N.J.S.A. 40A:12A-5(g), a municipality may grant a long-term tax exemption to property located within an Urban Enterprise Zone; and

**WHEREAS**, the Township Council duly adopted a redevelopment plan by Ordinance MC No. 3351 dated September 11, 2007, to govern the redevelopment of certain properties within and contiguous to the UEZ (as amended, the **"Redevelopment Plan**") in accordance with N.J.S.A. 40A:12A-7; and

**WHEREAS**, 530 Chancellor Urban Renewal LLC (the "**Entity**") is the owner of certain property located within the UEZ, which property is identified on the official tax map of the Township as Block 187, Lot 2.01 and 2.02 and identified in the Township tax records as 508-534 Chancellor Avenue, Irvington, New Jersey 07111 (the "**Property**"); and

**WHEREAS**, the Entity propose to undertake the design, development, financing, and construction a four (4) story U-shaped self-storage facility on the property, featuring 1,032 storage units, which will range from 25 square feet to 325 square feet, plus space for parking and loading (the "**Project**"); and

**WHEREAS**, in order to ensure the financial feasibility of the Project, the Entity made application to the Township requesting a long-term tax exemption and financial agreement pursuant to the Long-Term Tax Exemption Law, *N.J.S.A.* 40A:20-1 *et seq.*, which application is on file with the Township Clerk (the "**Application**"); and

**WHEREAS**, the Entity has represented to the Township that the Project would not be feasible in its intended scope but for the provision of financial assistance by the Township; and

WHEREAS, after review of the Application, the Mayor recommended that the Application be approved; and

**WHEREAS**, after review of the Application, the Township Council now desires to approve the Application and to authorize the execution of the proposed form of financial agreement (the "**Financial Agreement**") in substantially the form attached hereto as <u>Exhibit A</u>, and by this reference incorporated herein as may be modified in consultation with counsel as set forth herein; and

**WHEREAS**, the Township hereby determines that the assistance provided to the Project pursuant to the Financial Agreement will be a significant inducement for the Entity to proceed with the Project and that based on information set forth in the Application, the Project would not be feasible without such assistance,

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Irvington, in the County of Essex, New Jersey, as follows:

# I. GENERAL

The aforementioned recitals are incorporated herein as though fully set forth at length.

# II. APPLICATION FOR EXEMPTION APPROVED

The Application, which is on file with the Township Clerk and which has been recommended for approval to the Township Council by the Mayor, is hereby accepted and approved.

# III. EXECUTION OF FINANCIAL AGREEMENT AUTHORIZED

- (a) The Mayor is hereby authorized to execute the Financial Agreement, substantially in the form attached hereto as <u>Exhibit A</u>, subject to modification or revision deemed necessary or appropriate by the Township in consultation with counsel, and to take all other necessary or appropriate action to effectuate such Financial Agreement.
- (b) The Township Clerk is hereby authorized and directed, upon the execution of the Financial Agreement in accordance with the terms of Section III(a) hereof, to attest to the signature of the Mayor upon such document and is hereby further authorized and directed to affix the corporate seal of the Township upon such document.
- (c) In accordance with P.L. 2015, c. 247, within ten (10) calendar days following the later of the effective date of this Ordinance or the execution of the Financial Agreement by the Entity, the Township Clerk shall transmit a certified copy of this Ordinance and the Financial Agreement to the chief financial officer of Essex County and to the Essex County Counsel for informational purposes, as well as to the Tax Assessor of the Township.

# **IV. SEVERABILITY**

If any part of this Ordinance shall be deemed invalid, such parts shall be severed and the invalidity thereby shall not affect the remaining parts of this Ordinance.

WHEREAS, the Township of Irvington has received concerns from its residents concerning the availability of resident parking on Oakland Street between Orange Avenue and Lenox Avenue, from 6:00 PM to 6:00 AM; and

WHEREAS, the difficulty of the residents in these area to locate parking at or near their homes has caused undue hardship on the residents of this area.

WHEREAS, the Municipal Council of the Township of Irvington wishes to acknowledge the Police Valor Award Recipients for their professional achievements and honor the men and women in public safety who have given the most to protect and serve the community; and

WHEREAS, the Irvington Public Safety Department-Police Division's, Officer Zaneyah Mansfield, Detective Sheraldine Frazier and Officer Shawn Stewart, Jr. are to be admired for their courageousness and diligence in risking their lives in a honorable way; and

WHEREAS, on May 27, 2022, at approximately 11:38 am, **Officer Zaneyah Mansfield** was dispatched to Investors Bank, 1065 Stuyvesant Avenue for a report of a bank robbery. Upon her arrival she was able to speak to the reporting person, the banker who stated that a Black male suspect approached her at station #1 between 1129 hours and 1135 hours. The suspect filled out a withdrawal slip with a note under it demanding money. The suspect also had a black bag and held it as if he had a weapon inside. The reporting person was able to contact the security officer witness and the emergency services about the incident that occurred, however, the suspect filed the scene; and

WHEREAS, the withdrawal slip was for \$100,000.00. The note the suspect had handed to the cashier, stated, the following: NO ALARMS!! NO POLICE!! STAY CALM!! ALL COMMUNICATIONS ARE TAPPED! IF YOU NOTIFY THE POLICE WE'LL KNOW. COOPERATE AND EVERYTHING WILL BE FINE. GIVE ME ALL THE MONEY YOU HAVE IN AN ENVELOPE LIKE A NORMAL WITHDRAWAL. IF I AM NOT OUTSIDE IN UNDER 5 MINUTES, EVERYONE WILL BE IN DANGER. COOPERATE AND EVERYTHING WILL BE FINE. <u>I'M CARRYING A GUN!!</u> (*this was underlined 3x*); and

WHEREAS, officers at the time were canvassing the surrounding area for the suspect wearing a black hat, gray shorts and a black t-shirt with blonde/black dreads. **Detective Sheraldine Frazier** and **Officer Shawn Stewart, Jr.** stopped a suspect at 305 Nesbit Terrace that fit the description sent over the radio. **Officer Mansfield** was able to transport the reporting person to identify the suspect which she confirmed it was the person that committed the crime. The reporting person was later transported to police headquarters to make a statement. The suspect was transported by **Detective Frazier** for further processing; and

WHEREAS, the Detective Bureau was contacted and responded to the scene to collect evidence and view video footage at Investors Bank. The Detective Bureau was able to view the footage and observed the suspect enter and leave the area. Upon further investigation the supposed weapon the suspect possessed was a Play Station remote controller. The note, withdrawal slip and the remote controller were taken into evidence by Detective Jonas; and

WHEREAS, the suspect was processed and charges with robbery and false public alarms was assigned a warrant number:

WHEREAS, the Irvington Public Safety Department-Police Division's, Sergeant Malik Sims, Officer Emmanuel Quinones, Officer Olufemi Adedeji And Detective Sgt. Stanton Holder are to be admired for their courageousness and diligence in risking their lives in a honorable way; and

WHEREAS, on July 5, 2023, at approximately 8:00 am, Officer Alex Dorleant responded to 114 Elmwood Avenue on report of a carjacking and kidnapping. Upon his arrival he met with the wife of the owner of the vehicle, who stated that an unknown suspect stole her husband's vehicle with her 7-year old son inside it; and

WHEREAS, she was the only person on the scene upon arrival. She stated her husband got in her vehicle, a 2011 gray Mercedes Benz GLK and went in search of his recently stolen 2012 black Mercedes Benz GL500 containing their son. She stated that at approximately 0750 hours, she and her husband were preparing to drop off their son to summer school. As she was gathering her belongings inside her home, her husband was outside of the home starting the vehicle and securing their son inside; and

WHEREAS, the home had surveillance cameras and Officer Dorleant was able to review footage. Once their son was secured in the vehicle, her husband went to get the recycling bin from the curb and place it in the backyard. Moments later, an unknown blue Hyundai sedan pulled up across the street. An unknown male suspect exited the passenger side of the vehicle. The suspect ran in the driveway, entered the vehicle, and fled the scene traveling east on Elmwood Avenue. Her husband momentarily chased the vehicle on foot before returning back and getting her vehicle; and

WHEREAS, Sergeant Malik Sims, Officer Emmanuel Quinones, and Officer Olufemi Adedeji were on the scene. Units began searching the area for the child and the vehicle. Moments later Officer Quinones located the vehicle in the area of Laurel Avenue and Grant Place. No suspects were on the scene. However, their son was still in the vehicle and in good condition. He is an autistic child and a mute. RWJ EMS was notified; however, the mother declined medical attention for her child. The vehicle was towed by Officer Quinones and placed in inside storage. A consent to search was given by the husband and signed; and

WHEREAS, **Detective Sgt. Stanton Holder** responded on the scene. Surveillance footages were reviewed and downloaded from the neighboring Elmwood Terrace and Avenue homes. A BOLO announcement over the air proved the suspected vehicle to be a 2015 blue Hyundai Sonata bearing NJ Registration was stolen outside of the Township of Irvington. While completing this report, the suspects in the vehicle were conducting numerous criminal offenses in other jurisdictions:

The occupants were then assisted out of the structure and turned over to EMS for transport to Newark Beth Israel Medical Center for observation and treatment; and

WHEREAS, after completing the ladder rescue, Ladder 42 crew members **Lt. Velez** and **FF Ventura** entered the structure to assist with primary search of the second floor. While all responding members on the scene operated with teamwork, capability and dedication, resulting in the successful rescue of two (2) disoriented trapped occupants and the prompt extinguishment of the fire, the actions of the noted members stand above the rest; and

WHEREAS, these members' abilities to act immediately are a testament of their collective courage, and commitment to their duties:
